

AVECS™ PRO-ACT LIFETIME SAMPLE WARRANTY

AVECS warrants its product, AVECS PRO-ACT, to be free from material defects and that the product conforms to its specification of ceasing moisture migration and the de-bonding of floorcoverings out of or through the concrete slab itself for a period of lifetime when used in conjunction with ACI recommended wet curing OR AVECS approved curing agent and flooring contractor utilizes an AVECS approved waterproof quality filler at saw cuts and/or minor slab cracks. The warranty is provided in good faith if AVECS Pro-Act is installed according to and in compliance with AVECS specifications, dose rates and recommendations. AVECS requires avoiding use of any curing agent/bonding agent that contains paraffin, petroleum/oil, de-bonding agents, cleaning agents, dirt, or foreign substance that can inhibit bond and that any of the aforementioned be removed according to industry/manufacturers guidelines and recommendations. Please refer to specific manufacturers' recommendations for proper removal via manufacturers' data sheet. AVECS also prohibits use of shrink reducing admixtures in same mix as Pro-Act. AVECS requires a cylinder from every pour containing Pro-Act admixture no matter how small be taken at point of placement and held by either GC or ready-mix supplier and held in accordance with ACI guidelines for a period to be determined by AVECS before project commencement. A cylinder shall be taken by AVECS on every critical interior slab pour and tested at our expense via ASTM D-5084 perm testing. No other field testing (RH of CC) are allowed other than pH and ASTM D-4263 Mat testing which are required of flooring contractor with documented results provided to AVECS. If any floorcovering damage due to AVECS negligence and failure to cease moisture migration either out of or through the treated slab AVECS will, at its own expense, repair the affected area with an AVECS approved topical sealer and either replace or repair same affected area with the same or comparable flooring finish pro-rated at AVECS discretion. AVECS makes no other warranty, either implied or expressed and cannot be held liable for substandard concrete mixing, finishing, and slab cracks that occur from it nor are we responsible for control and/or expansion joints as sources of moisture migration or problems caused by use of other concrete additives. The sole remedy of the purchaser for any and all claims regarding AVECS Pro-Act alleged breach of warranty/contract, negligence, liability or otherwise is the remediation of affected area topically with AVECS RE-ACT product and the repair and/or replacement of floorcoverings of said area(s), solely at the discretion of AVECS LLC. All claims regarding this product(s) must be submitted in writing to AVECS within the life of the slab. In no case will AVECS be liable for punitive, consequential, special or incidental damages which would include loss of profit or use of area due to down time. AVECS reserves the right to inspect any potential claim and if any further testing is required AVECS will coordinate those tests and if results exonerate AVECS then cost of testing shall be responsibility of GC and paid in full before warranty is issued. Warranty is enforced upon AVECS receiving the following project information: Mix design prior to placement with approval, cement truck batch tickets, and

participation in a pre-con conference call including (approved) GC project manager, flatwork rep, project architect and AVECS representative. Prior to flooring installation, the installing floorcovering contractor MUST perform and document via date/time stamp photos ASTM F3311-19 Mat/Bond Test according to RFCI guidelines and results registered with AVECS as well as test for Ph levels and correct if needed according to RFCI/Industry guidelines. AVECS warranty has no upper limits on either Calcium Chloride or Relative Humidity therefore only recognizes ASTM D-5084 to prove its success and issue warranty. All accounts must be paid in full before warranty is issued by AVECS LLC.
